I. QUALIFICATION & EXPERIENCE:

- 1. Bachelor of Medicine and Bachelor of Surgery (M.B.B.S.), shall compulsorily be registered with respective State Medical Council.
- 2. Candidate should have at least two years relevant experience in Medical Institute / Hospital / Industrial Establishment post valid registration with State Medical Council.

II. SELECTION CRITERIA:

Following weightages shall be assigned to different parameters in the selection process:-

Qualification	70 marks (60 marks for essential qualification & up to 10 marks	
	for any relevant higher qualifications)	
Interview	30 marks	
Total	100 marks	

- 1. The breakup of 10 marks for such higher qualification shall be considered as follows:
 - a) Where a Bachelor's degree in the relevant field (M.B.B.S.) is the minimum prescribed qualification, 5 marks shall be given to a Master's degree in the relevant field (e.g. MD/MS).
 - b) Further additional 5 marks shall be given to a Post Master's qualification in the relevant field (e.g. M.Ch/ DM).

- 2. The higher qualifications considered for granting additional marks shall need to be in line, for example an MBA in Hospital Administration shall not be considered as an inline qualifications where M.B.B.S. is the essential qualification.
- 3. Qualifying marks in the interview shall be 18 marks.

III. FINALIZATION OF MERIT LIST:

- 1. Candidates who qualify in the interview shall be empaneled in the Merit List.
- 2. Offer of appointment shall be issued to the candidates based on their relative rank in the Merit List prepared on the sum total of marks scored by the candidate in qualification and interview.
- 3. In case of a tie in the total marks scored between two or more candidates, then the candidate who scores more marks in interview shall be considered senior. In case there too the marks are equal then the candidate who is older in age shall be considered for issue of offer of appointment.
- 4. Appointment of selected candidate will be subject to production of Medical Fitness Certificate as per extant rules of ECIL.

IV. DOCUMENTS TO CARRY:

Candidates are required to fill the Application Form available in ECIL Careers web page and walk-in along with the following documents. Candidates will be allowed for Personal Interview only after successful document verification.

- 1. Matriculation/10th Standard or equivalent certificate as proof of Date of Birth;
- 2. Identity proof issued by Govt., like Aadhar, PAN, Driving License, Passport etc.;
- 3. Qualification supporting documents (M.B.B.S. Degree);
- 4. Internship Completion Certificate;
- 5. Valid Registration Certificate with the respective State Medical Council.
- 6. Service certificates related to the experience;
- 7. Proof of Higher Qualification (if any);
- 8. No Objection Certificate (NOC) from existing employer, in case the candidate is engaged in a State / Central Govt. Enterprises.

Inability of the candidates to produce the requisite documents at the time of document verification shall render them liable for non-consideration of their candidature.
