**No individual call letter will be issued to any candidate in any mode.**



The candidates are also directed to submit a copy of the admit card of the Stenography test/written examination and two recent passport size color photographs. The self-attested photocopies of the documents shall have to be handed over at the time of the Interview/Viva-voce. Those candidates who are already employed in the Central/State Govt. Service or Undertakings shall have to produce *No Objection Certificate (NOC)* from the present employer.
